QF-840-3.S1 SUPPLEMENTAL ACQUISITION CLAUSES

FEDERAL ACQUISITION REGULATION (FAR) AND DEFENSE FEDERAL ACQUISITION REGULATION SUPPLEMENT (DFARS)
FLOWDOWN PROVISIONS FOR SUBCONTRACTS/PURCHASE ORDERS FOR NON-COMMERCIAL ITEMS UNDER A UNITED
STATES DEPARTMENT OF DEFENSE PRIME CONTRACT

A. INCORPORATION OF FAR AND DFARS CLAUSES

The FAR and DFARS clauses referenced in Table 1 are incorporated herein by reference, with the same force and effect as if they were given in full text, and are applicable, including any notes following the clause description, to this Contract. If the substance of any of the clauses in Table 1 is different from the substance incorporated and controlled by US Government FARS and DFARS Standard, the US Government Standard will apply. Seller shall include in each lower-tier subcontract the appropriate flow-down clauses as required by the FAR and DFARS clauses included in this Contract.

B. GOVERNMENT SUBCONTRACT

- (a) This Contract is entered into by the parties in support of a U.S. Government contract.
- (b) As used in the FAR and DFARS clauses referenced in Table 1 and otherwise in this Contract
 - 1. "Commercial Item" means a commercial item as defined in FAR 2.101.
 - 2. "Commercially available off-the-shelf (COTS) item" means a COTS item as defined in FAR 2.101
 - 3. "Contract" means this contract.
 - 4. "Contracting Officer" shall mean the U.S. Government Contracting Officer for government prime contract under which this Contract is entered.
 - 5. "Contractor" and "Offeror" means the SELLER, which is the party identified on the face of the Contract with whom King Machine is contracting, acting as the immediate subcontractor to KING MACHINE.
 - 6. "Prime Contract" means the contract between KING MACHINE and the U.S. Government or between KING MACHINE and its higher-tier contractor who has a contract with the U.S. Government.
 - 7. "Subcontract" means any contract placed by SELLER or lower-tier subcontractors under this Contract

C. NOTES

- (a) The following notes apply to the clauses incorporated in Table 1.
 - 1. Where appropriate substitute "KING MACHINE" for "Government" or "United States" throughout these clauses.



2. Where appropriate substitute "KING MACHINE Procurement Representative" for "Contracting Officer", "Administrative Contracting Officer" and "ACO" throughout these clauses.
3. Where appropriate insert "and KING MACHINE" after "Government" throughout these clauses.
4. Where appropriate insert "or KING MACHINE" after "Government" throughout these clauses.
5. Communication/notification required under these clauses from/to SELLER to/from the Contracting Officer shall be through KING MACHINE.
6. Where appropriate insert "and KING MACHINE" after "Contracting Officer", throughout these clauses.
7. Where appropriate insert "or KING MACHINE Procurement Representative" after "Contracting Officer", throughout these clauses.

D. AMENDMENTS REQUIRED BY PRIME CONTRACT

Seller agree that upon the request of KING MACHINE it will negotiate in good faith with KING MACHINE relative to amendments to this Contract to incorporate additional provisions herein or to change provisions hereof, as KING MACHINE may reasonably deem necessary in order to comply with the provisions of the applicable Prime Contract or with the provisions of amendments to such Prime Contract. If any such amendment to this Contract causes an increase or decrease in cost of, or the time required for, performance of any part of the Work under this Contract, an equitable adjustment shall be made.

E. PRESERVATION OF THE GOVERNMENT'S RIGHTS

If KING MACHINE furnishes designs, drawings, special tooling, equipment, engineering data, or other technical or proprietary information (Furnished Item) which the U.S. Government owns or has the right to authorize the use of, nothing herein shall be construed to mean KING MACHINE, acting on its own behalf, may modify or limit any rights the Government may have to authorize SELLR's use of such Furnished items in support of the U.S. Government prime contracts.
